Browser Information

The IAS website analyzes website logs to assist with improving the value and scope of information available on the website. This information is not personally identifiable and we make no attempts to link the information with an individual. This information is kept confidential.

Cookies

A piece of information that is temporarily stored on your computer to allow the user to return to a recently visited page without searching. It is not necessary to have the cookies feature active to view our website. However, your computer may automatically store cookies - please check your individual computer setup.

Medical Information

We do not sell, lease, or rent personal medical information between our members, visitors or third parties. We reserve the right to forward your information to a support coordinator when requests are made for support.
